Kerry Fox said that it is now time to start worrying about our costs. He has contacted the Lancaster County Event Center for a sample bill. He wanted it before tonight's meeting. The response was that Stephanie was working on a contract with a sample invoice. This morning he still hasn't had a response. The cost is expected to be around \$19,000. And it still takes around 280 volunteers to work the swap meet.

He has a list of jobs and needs verification of approval to do those same jobs from the clubs. The Lincoln Rebels has not responded to our request as of tonight on whether or not they have the people they need to complete their assignment.

Please let Kerry know if any of your clubs want the 3:00am overnight job as the Corvette Club might not want this job this year. The Omaha Rebels said they would be interested. Kerry asked if anyone else would be interested in working, there were no takers. One way or another Kerry promised a contract by the ENWICC meeting in Omaha in the month of December 2019. He knows that the Lancaster Event Center has done a lot of improvements this past year so Kerry is expecting an increase for them to pay for their rodeo. Otherwise, we will look at the costs when he gets a preliminary bill. He also said that our Eastern Nebraska Western Iowa Car Council Facebook page is up and running.

Seven Mile Ridez car club president, Myles Rasmussen asked for inclusion into the Car Council this evening. They have approximately 90 cars at the Prague car show each year. Last year they took over the management of the Wahoo Swap meet. They tried to do their best with this. This past fall they did pretty good. At least they had a good turnout without the weather being rainy. He brought calendars for distribution. They have approximately 20 members. The club cars are a mix of all makes. From Highway 92 to Prague Nebraska is 7 miles, which is how they came up with their name. They give away 2 scholarship each year. One to high school seniors of \$500 and a \$1000 scholarship to a college student that gives back to the community. The formed the club approximately 10 years ago.

AS A SIDE NOTE:

As a side note, a couple of our members went to Senator Bruce Bosselman to hopefully make it possible to reinstate the junk title. It was gotten rid of in the 1960's. He wants to qualify an inspector for a statewide position. Like a restoration car company or a Model "A" car club member. He also wants to draft up a description that it is a safe vehicle. The DMV only checks to make sure it is not stolen.

If you buy a car that has a junk title it currently cannot be titled again. There was a car in Ceresco that had a junk title and he was rebuilding it and couldn't get a title for the car. The state doesn't have qualified people to be able to say that the car should be able to be titled. Kerry Fox said that in the past we were always worried about the liability for the person that was serving as an inspector. What happens when they certify a car as being a certain age and make and model and then later on they find out there was a mistake made. How much would it cost the inspector for his liability insurance?


